# **Meeting Notes**

## 1. WELCOME and INTRODUCTIONS

# 2. OFFICERS

- a. Board voted/approved Jim Kniss as Vice President, Northern Region
- b. Board voted/approved Yuying Li as Membership Chair

# 3. 2007 CALGIS CONFERENCE

- April 4-6, 2007
  - a. Lorenda distributed postcards to Board members to hand out at the conference.

# 4. URISA NATIONAL CONFERENCE

- September 25-29, 2006, Vancouver, BC
  - a. Lorenda will be attending
  - b. Wendy Francis stated attendance is at 700+, there are more exhibits and speakers this year, and there is significant Federal Involvement.
    - The Chapter Leaders Forum is scheduled on Monday at Noon with 7 past presidents on the next committee.
    - Next year's Conference scheduled for Washington D.C. tentatively at the end of August 2007.
    - SoCal chapter is one of 9 chapters that have contributed financial support towards the Social event at the conference. Great publicity for Chapters!

# 6. MEMBERSHIP

- Melisa Caric/Yuying Li
  - a. Melissa has transferred membership responsibilities and database to Yuying.

- b. Yuying is researching companies who store our membership roster and process new members and payments.
- c. Check the national URISA website as an example.
- d. Focus on marketing to students; only \$10. We need more marketing strategies, in addition to solicitation at conferences and membership drive.
- e. Lorenda to send an email to board soliciting ideas regarding suggestions for more networking events.

# 7. TREASURER'S REPORT

# Travel Budget

- a. In the past, we have subsidized travel for Ingrid Bruce, Chapter Relations Chair, and Lisa Lubeley URISA National Conference Liaison. Lisa's term with URISA National will officially end in September, will further support be required? Lorenda will talk to Lisa.
- b. Board discussed advance request for financial support, at the beginning of the year preferably, and what venues we want representation at? For example, GITA has not had URISA representation in past.
- c. What are the expectations of support? How will representation benefit URISA?
- d. Suggested that Board votes and approves future funding for travel/expenses.
- e. Possible travel support for Laszlo as Past President, and Dan's trip to URISA Nat'l in Washington D.C. next year (2007).
- f. Wendy Francis suggested possible travel to Arizona to support Brian Sovik with the organization/administration of the Southwestern Chapter.

# • Template for Proposed Budget Spreadsheet

- a. Tobias has sent travel form and spreadsheet to Lorenda; Lorenda will email to Board, we will discuss at next meeting.
- b. Tobias proposed that we allocate some of our current chapter funds to a separate account, with interest earnings. Lorenda Lee motioned for approval, motion seconded by T. Wolf.
- c. Tobias reported we are still having issues with our LA account. Signature on account is unrecognizable. Tobias can't gain access. Laszlo may have some past contact information.

# 8. WORKSHOPS/MEETINGS

- Finding meeting formats that work for members: half day workshop/meeting vs. full day workshops.
  - a. Local San Diego workshops typically afternoon. Easier for attendees to justify.
  - b. Workshops in other regions, to the North, typically work better full day (6 hrs +/-) and offer official URISA Workshop content at a very reasonable rate. This works well as a membership drive

# • Workshop Dates set:

a. San Diego Region Meeting date tentatively set for October 12<sup>th</sup> at 2pm. Location: North county, possibly Carlsbad. Lorenda will line up speakers.

- b. January/February technical workshop at Ventura County Fire Department in Ventura; plus tour of fire training facility; lunchtime BBQ (Jim Kniss). Workshop topic to be determined.
- Consider having themes i.e. transportation, planning, imagery acquisition, data acquisition, database building, geographic databases, etc. Consider field tours: SDSU Cesar lab; UCSD; Scripps research center.
- Wendy Francis suggested encouraging chapter members to become certified instructors who will be able to present local workshops in their regions.
  - a. A Northern California URISA certified workshop is being held in September; 1-day; free for members; \$30 for non-members. Geney Terry has engaged Certified National instructor Dr. David Arctur.
